you have the right to access your personal data and receive a copy thereof, to correct, delete, or limit processing,

you have the right to withdraw your consent to the processing of personal data at any time; withdrawal of consent does not affect the lawfulness of processing based on this consent before its withdrawal; you can withdraw your consent by writing to the above email address or postal address,

you have the right to lodge a complaint with the supervisory authority, i.e., the President of the Office for Personal Data Protection,

providing personal data is voluntary but necessary to participate in the competition for the PRODOMUS Rector's Award for participants of the Doctoral Forum of Jan Kochanowski University in Kielce,
